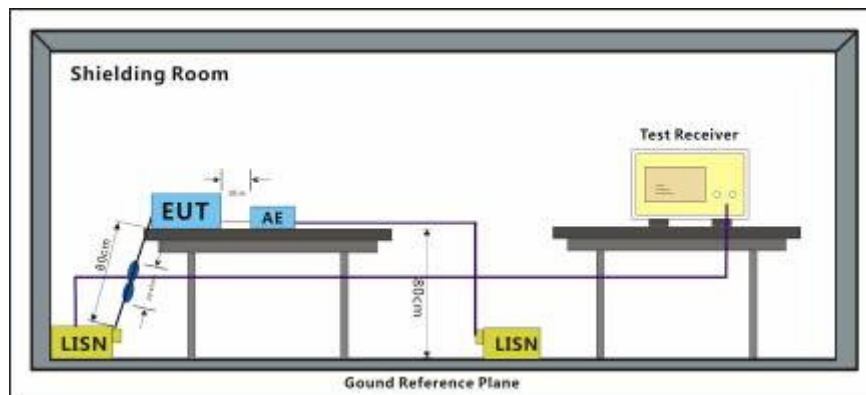

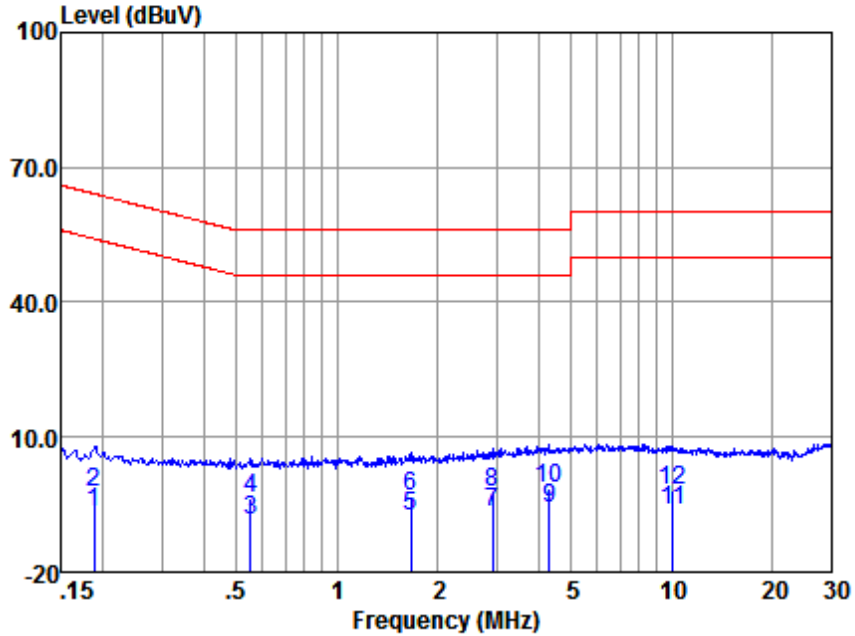
6.1.2 Test Setup Diagram

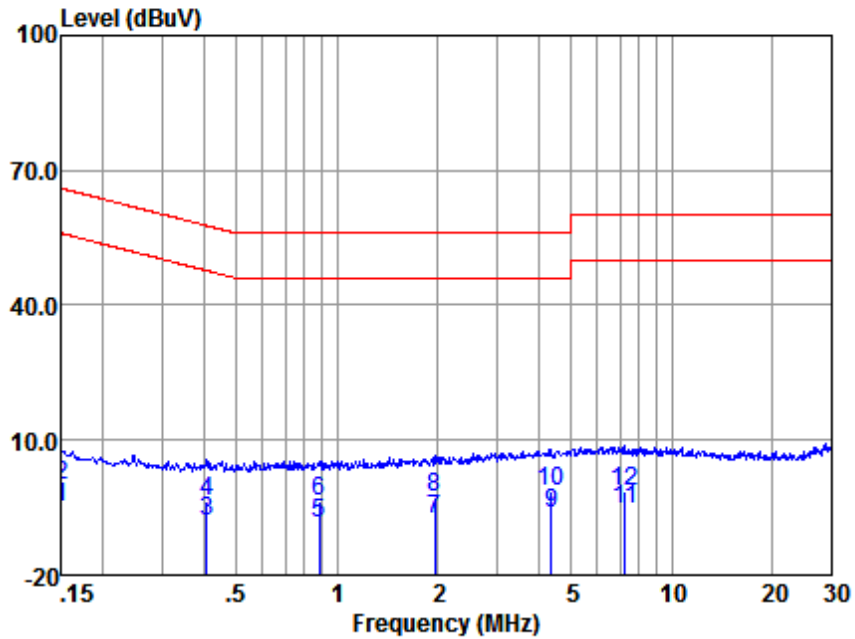

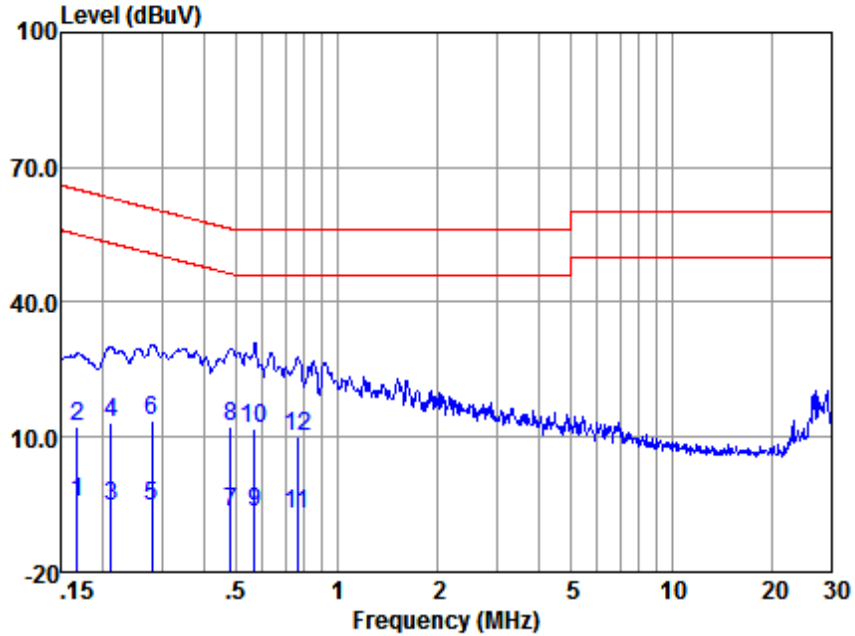

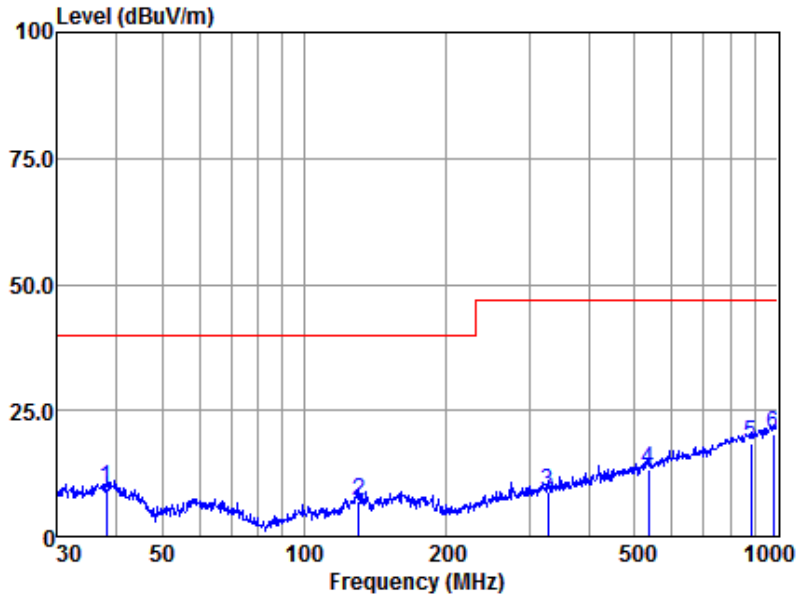
6.2.2 Test Setup Diagram

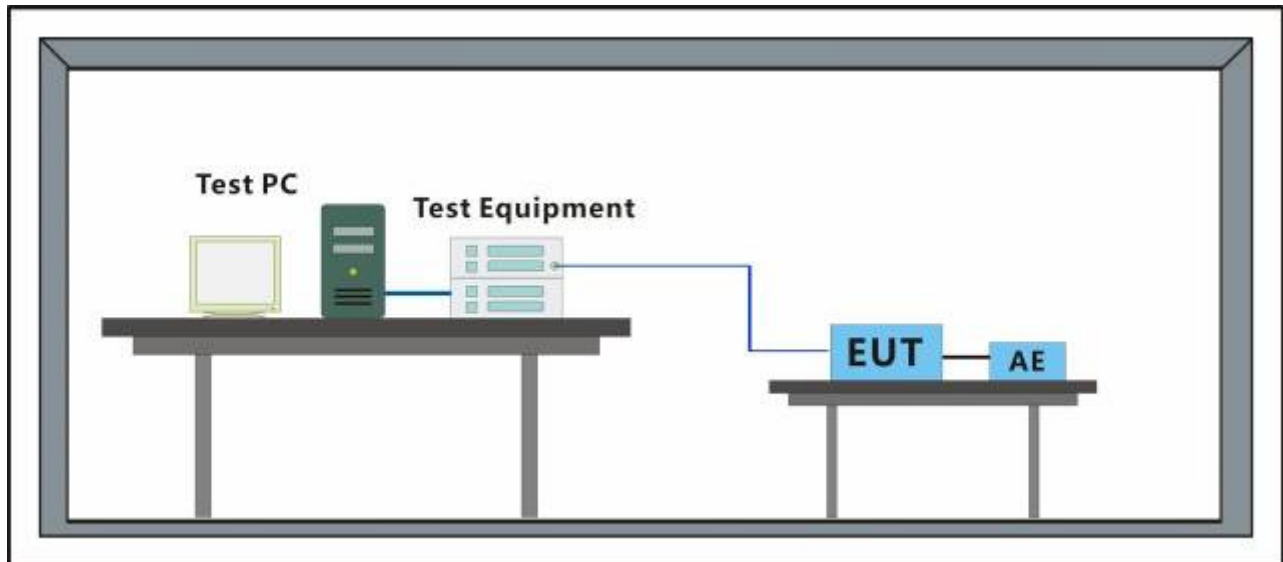

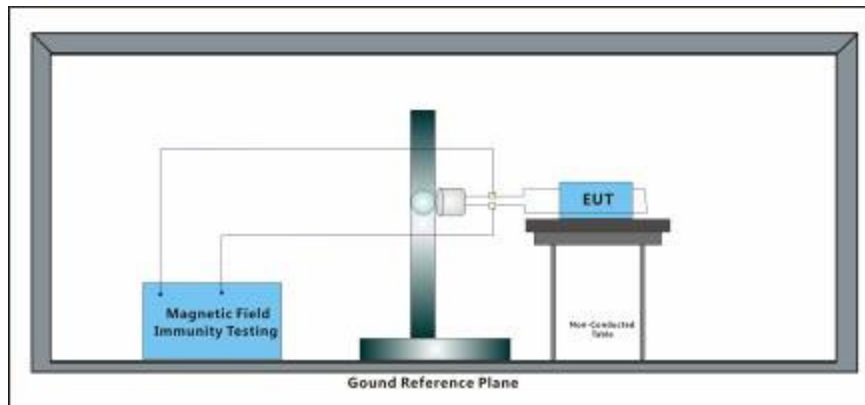

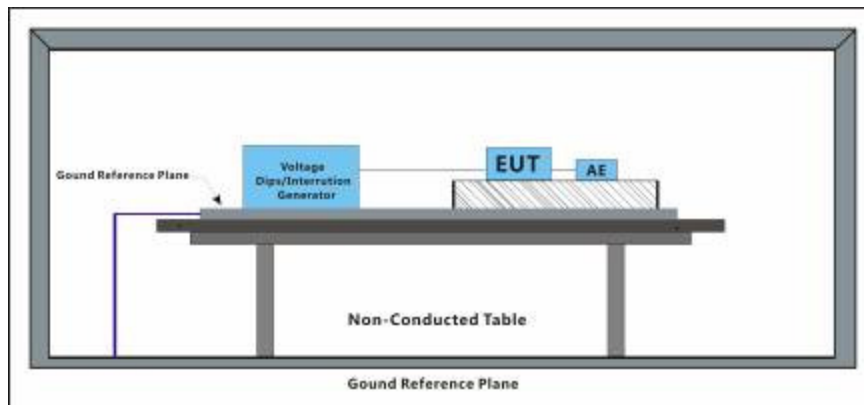

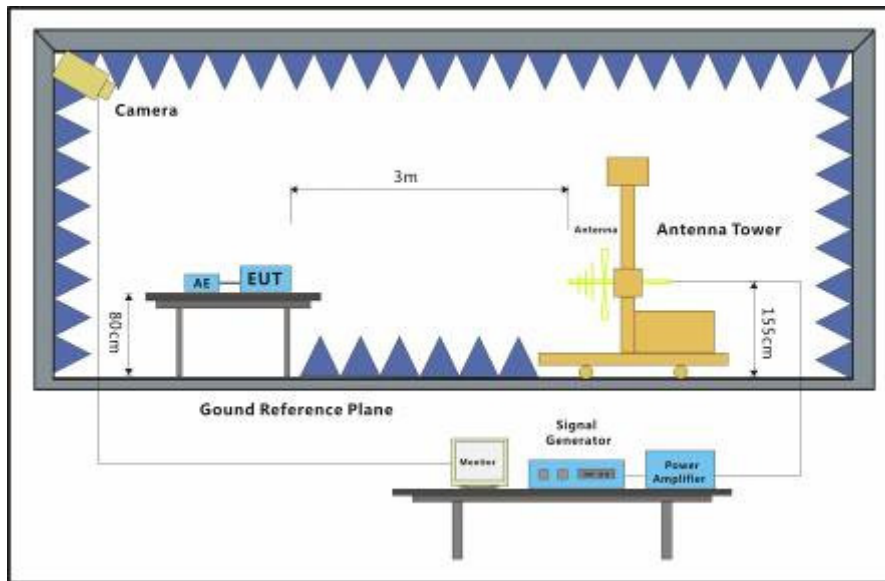

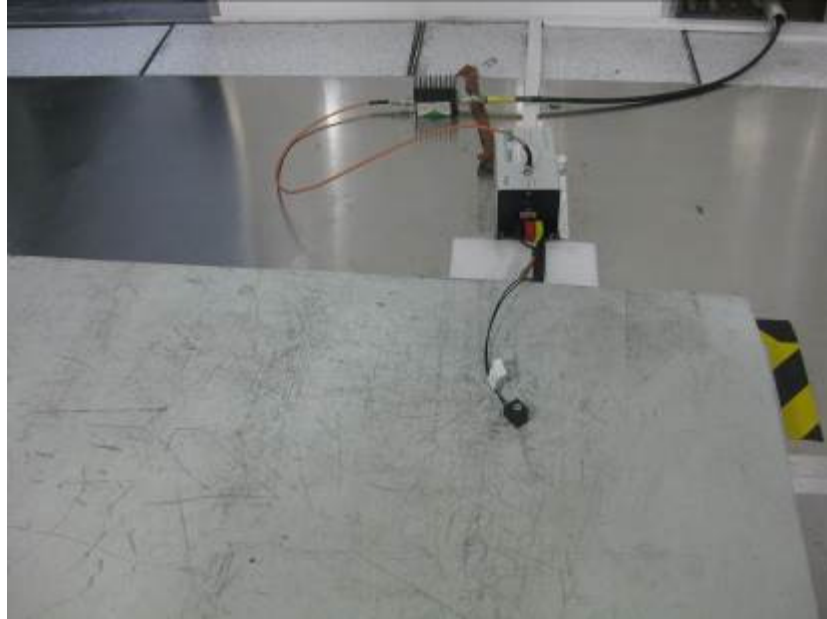




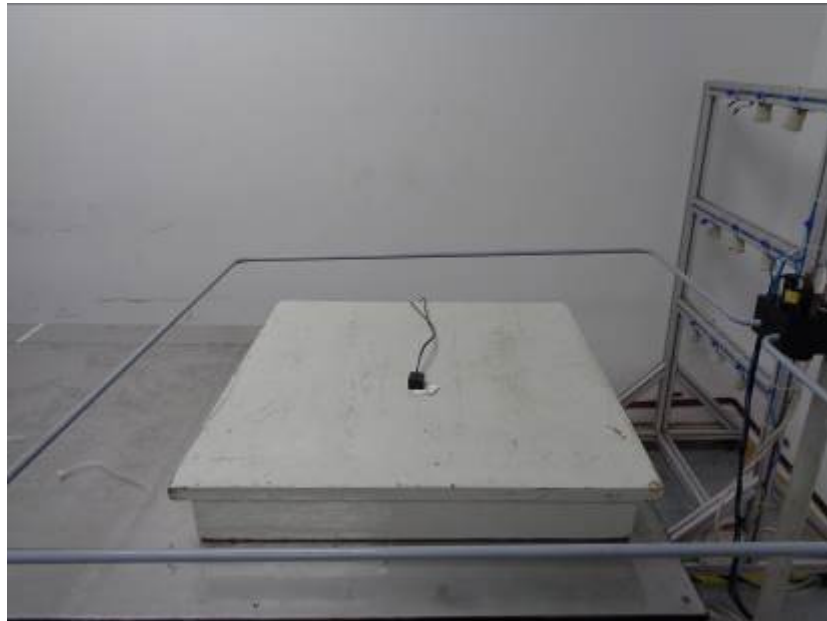
8.7 Conducted Immunity at Power Port (150kHz-80MHz) Test Setup

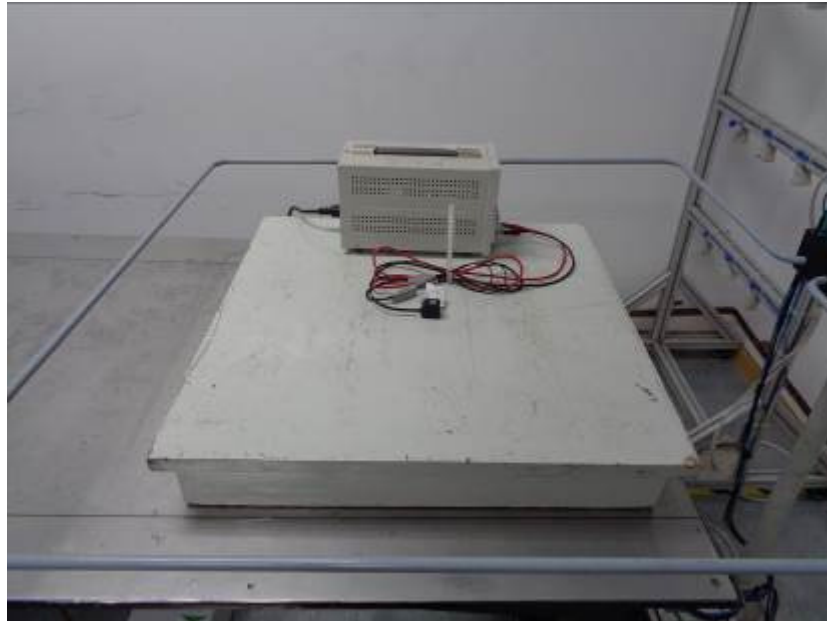






8.8 Power Frequency Magnetic Field Test Setup

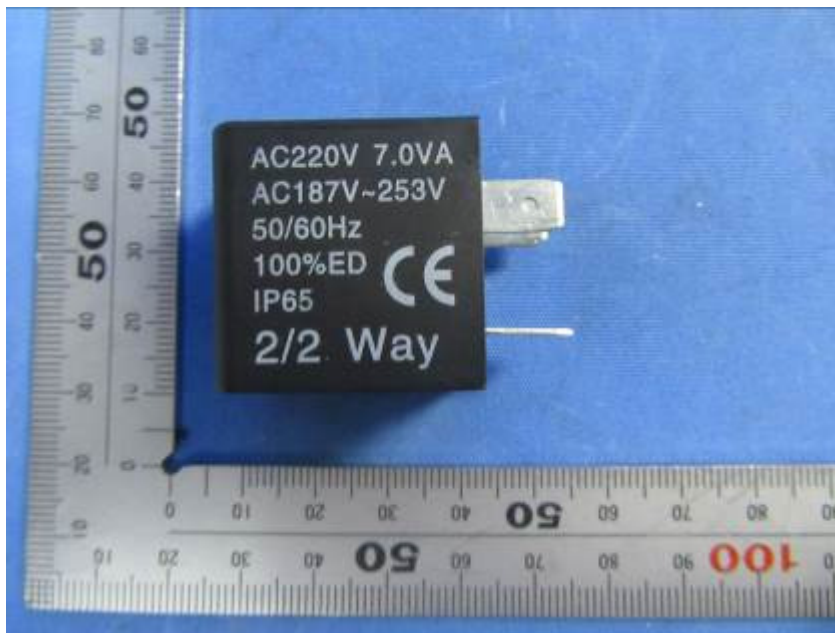
8.10 Radiated Immunity(80MHz-2.7GHz) Test Setup

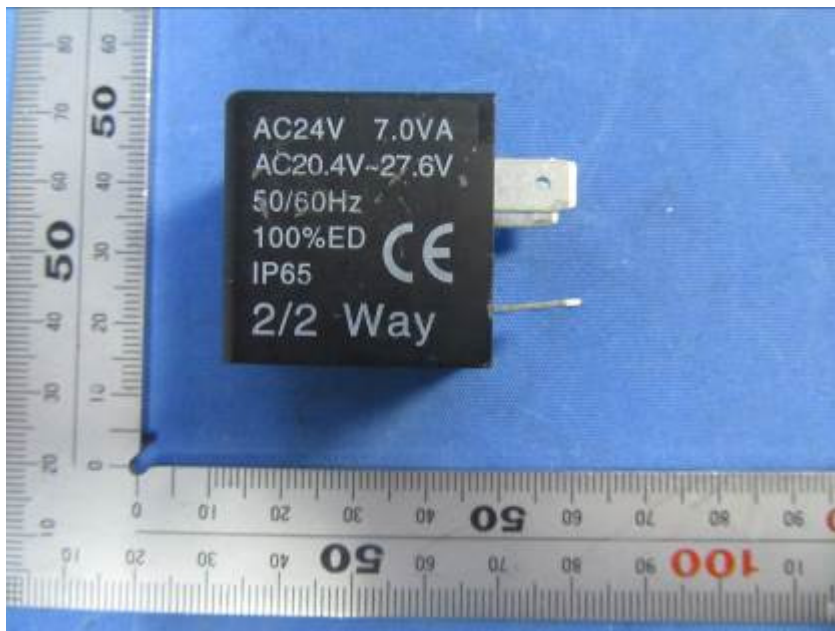


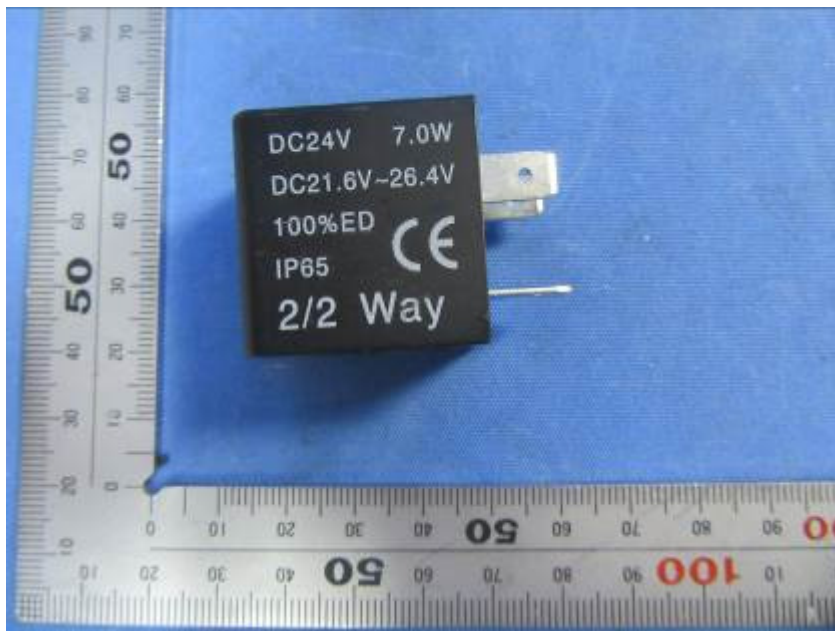
